#### Hi Students:

The following advising information is provided here to help guide you as you work to establish how the courses you have completed will meet application and program requirements at Lane. This information is subject to change and does not substitute for the information provided in the Nursing Application Information and forms packet at <a href="http://www.lanecc.edu/hp/nursing/admissions.htm">http://www.lanecc.edu/hp/nursing/admissions.htm</a>

All students will need to submit official sealed transcripts to Lane Enrollment Services office by the posted deadline date. Please review the Lane Application and Forms Packet for the year that you are applying. It is recommended that you bring unofficial copies of your transcripts for assistance with advising. You should also include copies of your transcripts with your application forms.

**Minimum application requirement**: Thirty of the forty-five qualifying credits must be completed by the end of Fall term 2011 and must include MTH 095 (or competency if a qualifying course has not been taken) and the first term of Anatomy and Physiology BI 231 or equivalent.

Additional qualifying credits to be used toward the 45-47 credits needed for application points or program requirements: Science courses: BI 112 (see page 4 Fall 2012 application), CH 112, BI 232, BI 233, BI 234; Math Courses: MTH 095 or MTH 111 or MTH 243; Writing Courses: WR 121, WR 122; Lifespan Development: PSY 215 or (HDFS 226 & PSY 236/PSY 235 & PSY 236); Human Relations, and Social Science courses - please refer in the Lane Catalog to the Human Relations/Social Science courses listed under the Associate Applied Science Degree page 48 (note fewer options than in previous catalog years); and qualifying credits as outlined in the Nursing Application for the year that you apply.

**Additional courses for Application Points**: Medical Terminology HO 100 and Nursing Program approved Diversity Course – please refer to <a href="http://www.lanecc.edu/hp/nursing/admissions.htm">http://www.lanecc.edu/hp/nursing/admissions.htm</a> and choose the "Diversity Courses" link.

**Additional course to complete degree requirement**: Writing – WR 123 (preferred) or 227 if WR 121 and/or WR 122 were completed prior to Summer 2010. Not required as a prerequisite recommended to be taken winter term of your first year in the Nursing Program.

Please review this information thoroughly first before submitting your questions.

# Steps to determine how your courses may be used to meet program and application requirements at Lane:

If you have completed courses at other institutions than Lane please use the Lane Course Equivalency Transfer Tool (CETT) <a href="http://www.lanecc.edu/es/transferringcredits.html">http://www.lanecc.edu/es/transferringcredits.html</a>. Please review the first page carefully and then choose "Look Up Your Transferable Credits." This shows how courses from another institution have previously been accepted at Lane.

If you see your courses listed and do not understand the results please email your questions to <a href="MursingProgram@lanecc.edu">NursingProgram@lanecc.edu</a> with the name of institution course was taken at and state if clarification needed, course numbering, course title and information provided in the Lane Transfer Tool.

Example: University of Oregon – completed Fall term 2005 BI 222 Human Genetics No Lab = BI 2XX Human Genetics No Lab (Sci)

If your course(s) are not listed as meeting a Lane program requirement you will need to complete the following steps to obtain a Course Equivalency or Substitution:

- 1. Course equivalency\*\* This can be obtained after a designated instructor or department representative has determined that the course you completed has enough content overlap that it meets criteria to be considered "equivalent." Once course equivalencies have been reviewed by a Lane Degree Evaluator they are added to the CETT.
- 2. Course substitution\*\* This can be obtained after a designated instructor or department representative determines that your course meets the content requirement to fulfill the program requirements for Nursing. Substitutions are not found in the CETT.

\*\*Once you are granted a course substitution or equivalency you will need to obtain a copy for your records and then include a copy of this form with your application.

#### The steps needed for each type of program requirement are provided below:

Math Course(s): Math Department Building 16, room 166 541-463-5392

- 1. MTH 095 Intermediate Algebra or higher This meets a program and application requirement. If your course appears on the Lane Transfer Tool (CETT) as equivalent to or higher than MTH 095 by Lane's course numbering then no further steps are needed. If your course(s) do not appear on this tool then you will need to go to the Math department with a course syllabus to request a course equivalency or substitution. Math courses listed as MTH1XX are considered 100-level math and higher than MTH 095; MTH 2XX is considered a 200-level math and are usually calculus or higher.
- 2. Math Prerequisite for taking BI 112/CH 112 Biobonds courses: Math courses that appear equivalent to or higher than MTH 052 on the Lane Transfer Tool will meet the prerequisite requirement for you to enroll in these. You will need to show an unofficial transcript to the <a href="Science Department">Science Department</a> in building 16. If it is determined that your course meets this requirement they will then be able to clear you to register.

**Science Courses:** Science Department Building 16, room 156 (541) 463-5446 If your courses are not listed on CETT then you will need to go to Science Department with course syllabi and you will be referred to the designated instructor to make the determination if your course work meets criteria for a course substitution or equivalency.

- 1. **Biology with Genetics:** Lane's BI 112 plus Lane's complete Anatomy and Physiology series (BI 231,232,233) meets this requirement. Courses completed more than seven years prior to Fall entry into the program may not meet this requirement. Please refer to the courses listed in the Lane Application and Information Forms packet for the year you are applying <a href="http://www.lanecc.edu/hp/nursing/admissions.htm">http://www.lanecc.edu/hp/nursing/admissions.htm</a> for other courses that will meet this requirement.
- 2. **Prior Biology or Chemistry**: You may have sufficient course work completed in one or both of these areas to meet the prerequisite requirement (BI 112/CH112) to take Anatomy and Physiology, first term. This can be established by starting with taking unofficial transcripts to the science department. This may result in one or both courses being waived. If it is determined that you only need BI 112 or only need CH 112 then they will provide you with a specific course registration number. In some cases you may need to present a syllabus if it is requested. Being cleared to register for BI 231 does not guarantee the Biology with Genetics program requirement has been met. Courses completed more than seven years prior to Fall entry into the nursing program may not meet the requirement.
- 3. Anatomy and Physiology sequence (BI 231,232,233) BI 231 is required to apply. Students who have completed the Anatomy and Physiology sequence by date of application will be eligible for additional application points. If your coursework does appear on CETT tool then you will not need to take steps to get a course substitution or equivalent. The last course in your sequence must be taken within seven years prior to your Fall entry once accepted into the nursing program. For Fall 2012 this means the most recent course must be completed by the end of Fall term 2005. If your course work was completed prior to this timeframe then the Nursing Program Coordinator will need to approve use of these courses. Students who believe their course work and experience may meet the criteria should contact the Nursing Program Coordinator Tricia Tully tullyt@lanecc.edu.
- 4. **Microbiology BI 234:** This meets a program requirement. It is not a prerequisite but must be completed by winter term of your first year in the Nursing Program.. The course must be completed within 7 years prior to your Fall term entry.

**English Composition sequence**: <u>Language, Literature and Communication Department</u>, Center Building, room 457 (541) 463-5419

If WR 121 and WR 122 were completed summer term 2010 or later then these two courses will meet the program application and writing degree requirement and WR 123 or WR 227 are not required. If either WR 121 or WR 122 were completed prior to summer term 2010 then WR 123 or 227 will be required to complete the writing degree requirement. It is important to check the Lane Transfer Tool as some courses with the same course numbering transfer to Lane as a different course (e.g. WR 122 at some schools is Lane's WR 123).

- 1. WR 121 Introduction to Academic Writing if course completed prior to Summer term 2010 then remember three terms of writing will be required to complete the AAS Nursing degree. If your course appears on the CETT as equivalent to WR 121 then no further steps are needed.
- 2. WR 122 Composition: Argument, Style and Research if course completed prior to Summer term 2010 then remember three terms of writing will be required to complete the

- AAS Nursing degree. If your course appears on the CETT as equivalent to WR 122 then no further steps are needed.
- 3. WR 123, Composition: Research (preferred) or WR 227 Technical Writing For Fall 2012 is not a prerequisite but must be completed by Winter Term of your first year in the Nursing Program.

Prior course work – If your courses do not appear on the CETT you will need to take syllabi to the <u>Language</u>, <u>Literature and Communication Department</u> to determine if they meet criteria for a course equivalency or substitution. You will be referred to a designated instructor.

If you have completed a U.S. Bachelor's degree you may waive the application prerequisite requirement for WR 121 and WR 122 if you elect this option you will use qualifying courses to fulfill the 45 course credits required for admission to the program. – please review the Application Information and Forms packet for the year that you are applying to determine how your course work can be used for the application points.

If you have a Bachelor's degree from an institution outside of the US your writing courses are not waived. You will need to complete the writing degree requirement as described above. The only exception to this is if you granted a course substitution that is approved by a designated writing instructor, a degree evaluator and the program coordinator.

Nutrition FN 225: Health Professions Division – Building 30 and 4, 541-463-5617

Please review the Lane CETT. If your course is not listed you may need to obtain a course equivalency or substitution.

You will need to present a course syllabus to a designated Lane Nutrition instructor.

**Psychology Courses: Social Science Division** – Center Building, room 403 541-463-5427

- 1. PSY 201 General Psychology This course is not required to apply but can be used to meet the Social Science requirement for completion of the nursing degree and/or for application credits. PSY 201 is a required prerequisite to take PSY 215, PSY 235 or PSY 236. If your course is listed on the CETT you can take an unofficial transcript to the Social Science department. They will then be able to clear you to take PSY 215, PSY 235 or PSY 236. If your general psychology course is not listed then you will need to have your syllabus evaluated by a designated instructor.
- 2. Lifespan Development There are three options for completing this requirement at Lane. 1) PSY 215, 2) HDFS 226 Child Development and PSY 236 or 3) PSY 235 and PSY 236. If your prior college course work is not listed on the Transfer Grids or on the CETT you will need to take steps to obtain a course equivalency or substitution. Please go the Social Science department to be referred to a designated instructor. They will want to review a course syllabus. Note: PSY 236 is not being offered at Lane.

## **Diversity Courses:**

The preferred courses are HO 102 Diversity Issues in Health Care of ANTH 103 Cultural Anthropology. If you have a course that appears on the CETT as equivalent to a course option as defined no further steps are needed. The 11/12 Lane Catalog courses listed on pages 42-44 marked by an asterisk are considered Diversity Course options. If your course is listed as equivalent to one of these courses no further steps are needed. If you believe you have completed a course that may meet the Diversity Course requirement email <a href="mailto:NursingProgram@lanecc.edu">NursingProgram@lanecc.edu</a> with name of course, institution course completed at and term and year completed.

**Human Relations:** See Lane 11/12 Catalog page 48 for list of approved courses.

This course can be used to meet a program requirement and can be used toward application prerequisite credits. Please review the CETT and the Human Relations course list under the requirements for the Associate of Applied Science Degree requirements. If you have a course that appears on the CETT as one of the Human Relations courses then no further steps are needed. If not, and you believe that you have a CG numbered course that meets this requirement please bring a course syllabus to the Counseling department and ask to speak to a designated instructor. Otherwise, please email NursingProgram@lanecc.edu with your question.

Social Science: See Lane 11/12 Catalog page 48 for list of course subject prefixes

This course can be used to meet a program requirement and can be used toward application prerequisite credits. Please review the following list. Six credits minimum from one subject prefix – specified by program, or if not specified, chosen from the approved list in the catalog under AAS degree, Human Relations/Social Science. Additional social science credits may be from any of the social science areas as follows: Anthropology, Economics, Ethnic Studies, Geography, History, Human Relations (CG, formerly HD and HS prefixed courses), Philosophy, Political Science, Psychology, Religion, Sociology, or Women's Studies.
