RESPIRATORY CARE PRACTITIONER

APPLICATION REQUIREMENTS

New Applicants for Permanent License

Applicants who have completed an approved course of respiratory care training, passed the CRRT or RRT examination and achieved NBRC Certification;

Applicants must provide:

- Completed application;
- Payment of fees;
- Official documentation of passing CRTT or RRT scores requested by the applicant or mailed directly to the Health Licensing Agency from the **NBRC**

Equivalency Applicants for Permanent License

Applicants holding an active license in another state, or country in which the Board recognizes that state's education, examination and licensing requirements.

Applicants must provide:

- Completed Application
- Payment of fees
- Original Affidavit of Licensure mailed directly to the Health Licensing Agency from the licensing state verifying the respiratory care training course completed, type of examination taken, examination scores received and if certification was obtained though a national organization.

Note: An Affidavit of Licensure may be electronically transmitted to the Health Licensing Agency from the licensing state. Pre- Authorization for electronic transmission is required.

Application for Temporary Licensure

Applicants who have completed an approved training program but have not achieved a passing score on the qualifying examination.

Applicants must provide:

- Completed application;
- Payment of fees;
- Official transcript verifying * completion of the approved course of respiratory care training requested by the applicant and mailed directly to the Health Licensing Agency from the school.

PAYMENT OPTIONS

Payment of all fees must be for the exact amount required. Cash, check or money orders are acceptable forms of payment. All cash transactions require the exact amount, i.e. bill denominations, as monetary change is not available in conducting transactions with the agency.

EXAMINATION

All applicants for permanent licensure are required to pass a qualifying examination as prerequisite to licensure.

The approved examination is a national examination, which is provided by the National Board for Respiratory Care (NBRC).

Note: a state prepared examination approved by the board as being equivalent to the qualifying examination may be accepted in place of the NBRC examination as prerequisite for licensure.

SANCTION

OAR 331-730-0000 Grounds for Suspension, Revocation or Non-renewal of License or Probation.

As a condition of licensure, the Health Licensing Agency has authority to conduct a background check by using the Law Enforcement Data System (LEDS).

If you have been convicted of a crime, other than a misdemeanor that is directly related to the practice of Respiratory Care, the Health Licensing Agency may refuse licensure.

OAR 331-730-0000(5) Application Completion and Deadlines.

An applicant who has an outstanding civil fine or action in another state, county, city or country documented on the Affidavit of Licensure form, shall be prohibited from qualification for licensure until any or all fines and/or actions are resolved and verification of resolution from the originating state has been received.
